ARTICLES OF ORGANIZATION
FOR

The undersigned Manager of Grand Haven Realty, L.L.C. (the "Company") hereby executes and adopts the following Amended and Restated Articles of Organization pursuant to Chapter 605, Section 605.0202, Fla. Stat. under the Florida Revised Limited Liability Company Act which Amended and Restated Articles of Organization replace in their entirety the previously adopted Articles of Organization of Company filed with the Florida Secretary of State on September 16, 2010 and assigned document number L10000097390.

**ARTICLE I
NAME**

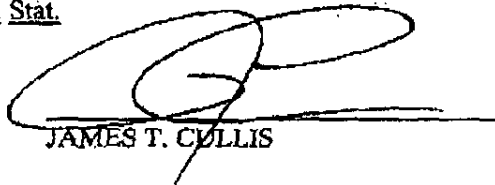
