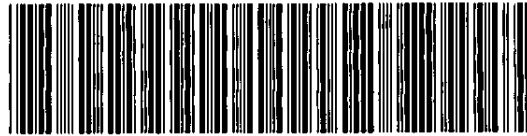

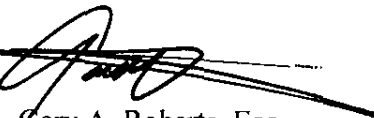

**ARTICLE I - Name:**

The name of the Professional Limited Liability Company is: Roberts & Meeks, P.L.

They shall be jointly, not separately, authorized to execute on any and all reports, forms, instructions, documents, papers, writings, agreements, and contracts, including but not limited to deeds, bills of sale, assignments, leases, promissory notes, mortgages, security agreements, and any other type or form of document by which property, property rights or services of the Company are transferred or encumbered or by which debts and obligations of the Company are created, incurred, or evidenced which are necessary, appropriate, or beneficial to carry out or further such decisions or actions.

Certain authority and/or decision making may be designated to a single member to act on behalf of the Company. However, such delegation must be mutually agreed upon and set forth in a subsequent Operating Agreement or writing precedent to such action or decision making.
