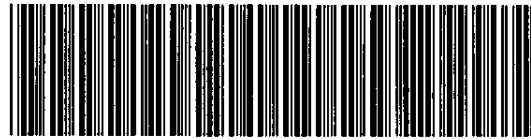



**ARTICLE II — Filing Date and Document Number:**


The Articles of Organization were filed on September 21, 2010 and assigned document number L10000098493.
