**ARTICLES OF ORGANIZATION
OF

**ARTICLE I
Name**

The name of this limited liability company is REVELATOR CAPITAL COMPANY LLC.

**ARTICLE II
Existence**

This limited liability company shall have perpetual existence.

**ARTICLE III
