The street address and mailing address of the principal office of the limited liability company is 2001 North Flagler Drive, West Palm Beach, FL 33407.

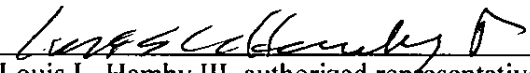
**ARTICLE III - INITIAL REGISTERED AGENT**

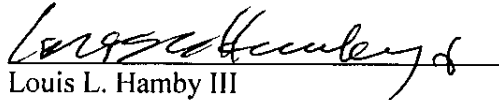
