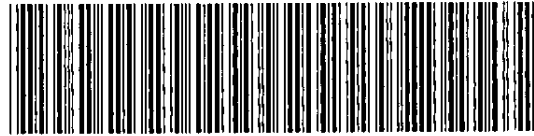

The purpose for which this company is formed is to engage in any lawful activity for which a company may be formed under applicable law.




