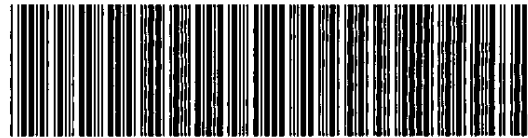

ARTICLES OF ORGANIZATION
OF

The limited liability company is designated to be managed by one or more managers and is, therefore, a manager-managed limited liability company.

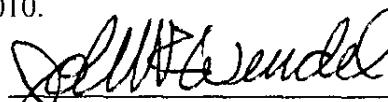
