**AMENDED AND RESTATED**  
**ARTICLES OF ORGANIZATION**  
**OF**

1. The Articles of Organization for this Limited Liability Company were filed on September 24, 2010 and assigned Florida document number L10000100334.

2. The name of this Limited Liability Company shall be Nassau Endodontics, PL, a professional limited liability company under the Professional Service Organization and Limited Liability Company Act, Chapter 621, Florida Statutes (hereinafter referred to as the "Act").

3. The Articles of Organization of the Limited Liability Company are hereby amended and restated in its entirety to read as follows:

**ARTICLE I**

The name of this Limited Liability Company shall be Nassau Endodontics, PL, a professional limited liability company.

**ARTICLE II**

Nassau Endodontics, PL., shall have perpetual existence.

**ARTICLE III**

The general purposes for which this Company is organized and proposed to be transacted, promoted and carried on, to do any and all of the things hereinafter mentioned are:

1. To engage in every phase and aspect of the practice of dentistry and to render professional dental services to any and all persons, firms and corporations and other entities and to the general public in the State of Florida and throughout the world unless prohibited by law.

2. To own real or personal property as may be necessary for the practice of dentistry.

3. To invest the funds of the Company in real estate, mortgages, stocks, bonds, or any other type of investments.

4. To have one or more offices, conduct and carry on its business and operation and promote its objectives within the State of Florida.

5. To, in general, carry on and transact any business in connection with or auxiliary to the foregoing, to have and exercise all of the powers conferred by the laws of Florida upon professional service organizations, and to do any or all of the things hereinabove set forth to the same extent as natural persons might or could do.

The foregoing clauses shall be construed both as objects and powers; and it is hereby expressly provided that the foregoing enumeration of specific powers of this Company; and the above and foregoing businesses enumerated are intended as illustrative and not restrictive, and this Company shall have the power to handle such business or businesses, either in its own behalf or as agent or broker for others, and shall further engage in any and all like and kindred businesses, which may be necessary or profitable in conjunction with the businesses above enumerated, and generally shall have and exercise all powers, privileges and immunities of businesses of like kind and nature under the laws of the State of Florida, and shall enjoy the privilege and immunities pertaining to such organizations under the laws of the State of Florida.

The principal place of business of Nassau Endodontics, P.L., is 5211 South Fletcher Avenue, Suite 230, Fernandina Beach, FL 32034, and the mailing address shall be P.O. Box 551260, Jacksonville, Florida 32255-1260, or such other place or places as the Members from time to time may determine.

Nassau Endodontics, P.L., will be managed by its Members. The initial Managing Members shall be Jeffrey W. Bowden, D.D.S. and Loandro R. Britto, D.D.S.
