ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZA

OF

JF HOLDINGS GROUP, L.L.C.

The undersigned, an authorized officer of JF HOLDINGS GROUP, L.L.C., a Florida limited liability company (the "Company"), desiring to amend the Articles of Organization of the Company pursuant to Section 608.411 of the Florida Limited Liability Company Act (the "Act"), states as follows:

- The name of the Company is IF HOLDINGS GROUP, L.L.C.
- 2. The date of filing of the original Articles of Organization of the Company was September 27, 2010, document number L10000101282.
- 3. The Articles of Organization of the Company are amended by deleting Article V, entitled "Management," in its entirety and inserting the following section in its place:

"ARTICLE V.

MANAGEMENT

The Company is to be managed by its Member(s), unless and until one or more managers are appointed in accordance with the Operating Agreement of the Company, in which case the Company shall be managed by one or more managers. The managers shall be elected as described in the Operating Agreement."

4.. The Articles of Organization of the Company are amended by adding Article VIII, entitled "Indemnification," as follows:

"ARTICLE VIII.

INDEMNIFICATION

Each individual or entity who is or was a member or manager of the Company (and the heirs, executor, personal representatives, administrators, successors or assigns of such individual or entity) who was or is made a party to, or is involved in any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, by reason of the fact that such person is or was a member or manager of the Company ("Indemnitee"), shall be indemnified and held harmless by the Company to the fullest extent permitted by applicable law, as the same exists or may hereafter be amended. In addition to the

indemnification conferred in this Article, the Indemnitoe shall also be entitled to nave paid directly by the Company the expenses reasonably incufred in defending any such proceeding against such Indemnitee in advance of its final disposition, to the fullest extent authorized by applicable law, as the same exists or may hereafter be amended. The rights and authority conformed in this Article shall not be exclusive of any other right which any person may have or hereafter acquire under any statute, provision of the Articles of Organization or the Operating Agreement of the Company, agreement, vote of Members or otherwise. Any repeal or amendment of this Article by the Members of the Company shall not adversely affect any right or protection of a member, management officer existing at the time of such repeal or amendment."

This Amendment was approved by unanimous consent of all the members and managers of the Company.
