ARTICLES OF ORGANIZATION OF ALPHA LABS LLC

The undersigned, being a duly authorized representative of the member(s), desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

ARTICLE I <u>NAME</u>

The name of the limited liability company is ALPHA LABS LLC (the "Company").

ARTICLE II ADDRESS

ARTICLE III REGISTERED AGENT AND OFFICE

The Company shall be conducted, carried on, and managed by at least one (1) Manager and is, therefore, a manager-managed Company. The Manager(s) shall also have the rights and responsibilities described in the Operating Agreement of the Company, if applicable.
