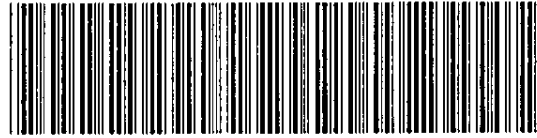

Pursuant to chapter 608, Florida Statutes, the undersigned, being a natural person who resides in the State of Florida, hereby acts as the authorized representative in adopting and filing the following articles of organization for the purpose of organizing a limited liability company under the Florida Limited Liability Company Act.

ARTICLE I  
(Name)

The initial street address of the corporation's registered office is 1415 Timberlane Road, and the initial registered agent for the corporation is Delonna Hartley.


ARTICLE VI


