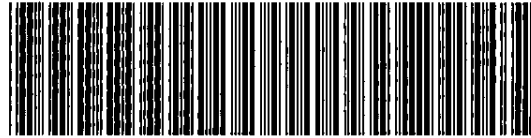

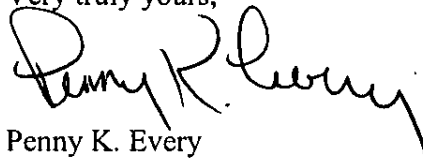

Name

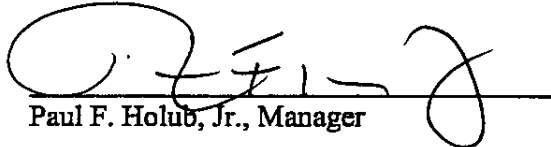

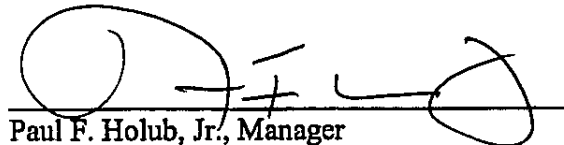

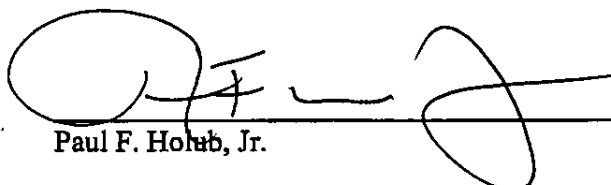
