- 3. <u>Terms of Merger, Method of Conversion</u>. The Merging Entities shall merge with and into Surviving Entity, which shall be the Surviving Entity. The members in the Merging Entities shall each hold, as a result of the merger, membership interests in the Surviving Entity, which are equal to such members' percentage membership interests as members in the Merging Entities. - 6. <u>Effective Date</u>. In accordance with Sections 608.438 and 608.4382 of the Act, the Certificate of Merger shall specify the "Effective Date," which shall be the date of the filing of the Certificate of Merger.
- 7. <u>Supplemental Action.</u> If at any time after the Effective Date, the Surviving Entity shall determine that any further conveyances, agreements, documents, instruments, and assurances or any further action is necessary or desirable to carry out the provisions of this Plan of Merger, the appropriate members or managers of the Surviving Entity or the Merging Entities, as the case may be, shall execute and deliver, on the request of the Surviving Entity, any and all proper conveyances, agreements, documents, instruments, and assurances and perform all necessary or proper acts, to vest, perfect, confirm, or record such title thereto in the Surviving Entity or to otherwise carry out the provisions of this Plan of Merger.
