ARTICLE VII - ADMISSION OF ADDITIONAL MEMBERS



ARTICLE IX - EFFECTIVE DATE


Pursuant to the provisions of Chapter 608, Florida Statutes, this limited liability company shall begin in existence upon the filing of these Articles of Organization.
