**ARTICLES OF AMENDMENT OF
THE ARTICLES OF ORGANIZATION
OF
AUTO CREDIT OF JACKSONVILLE, LLC**

A. The name of the limited liability company is Auto Credit of Jacksonville, LLC (the "Company").

B. The Articles of Organization of the Company were filed with the Florida Secretary of State on October 7, 2010 and assigned document number L10000105166.

C. Article II of the Articles of Organization is amended in its entirety to read as follows:

"ARTICLE II - PRINCIPAL OFFICE

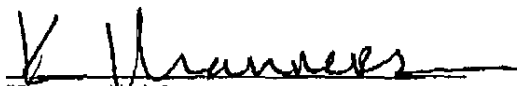
