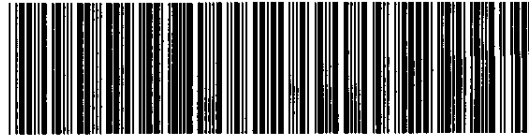


**ARTICLE VI -- Disqualification of Member or Employee**


