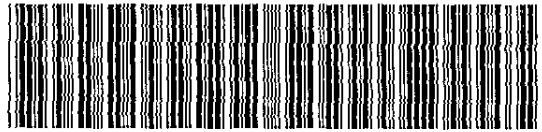

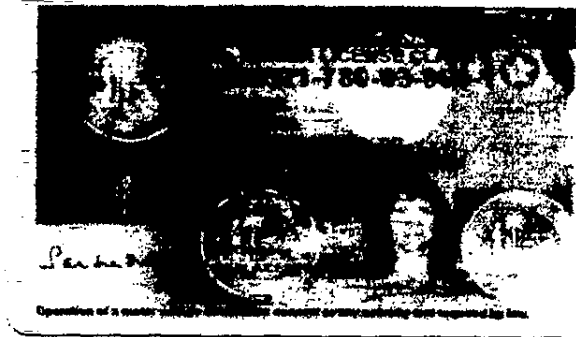

FINAL JUDGMENT OF DISSOLUTION OF MARRIAGE

THIS CAUSE came to be heard on June 26, 2015, upon the Wife's Amended Petition For Dissolution Of Marriage By Interlineation, and there being due proof and corroboration of residence, and the parties having entered into a Marital Settlement Agreement on May 13, 2015, and the Court being otherwise fully informed in the premises, the Court finds that it has jurisdiction of the parties and the subject matter of this action and, further, the Court finds that the marriage is irretrievably broken and that no useful purpose would be served by delaying entry of Final Judgment in this action, it is, therefore

ORDERED AND ADJUDGED as follows:

- 1. Jurisdiction:** The Court has jurisdiction over the subject matter and the parties.
- 2. Dissolution of Marriage:** The marriage of the Petitioner/Wife, SANDRA LEFLER, and the Respondent/Husband, JERRY P. LEFLER, is hereby dissolved because it is irretrievably broken.
- 3. Marital Settlement Agreement:** The Marital Settlement Agreement entered into by the parties on May 13, 2015, and introduced into evidence by the Wife as Exhibit I, be and the same

is hereby ratified and confirmed by this Court and made a part of the Judgment by reference, and the parties hereto are ordered to comply with the terms thereof.

4. Name Restoration: The Wife's former name is restored to her and she shall hereafter be known as Sandra Metsova.

5. Retention of Jurisdiction: The Court shall retain jurisdiction of this cause for the purpose of entering any and all such further orders and judgments as may be necessary pertaining to the enforcement of the executory provisions of this Judgment.
