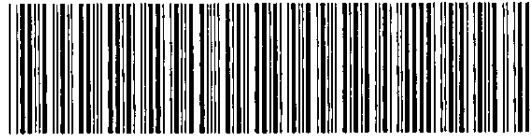

Normandy Investors Corporation is deleted as a Member/Manager of the Company.


2020 Ponce Investments, LLC is deleted as a Member/Manager of the Company.
