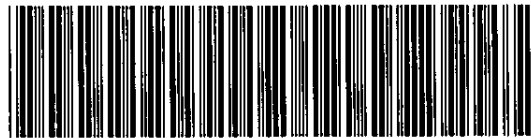

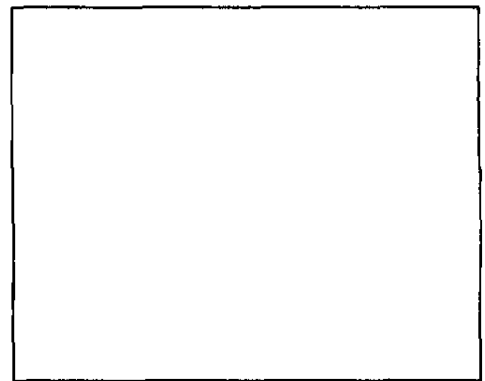

b. In all other respects, the Articles of Organization shall remain unchanged.


