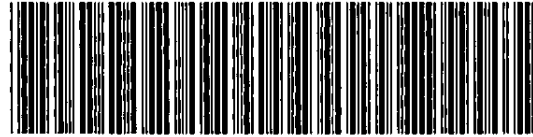

**SEVENTH:** There are no suits pending against the company in any court.


