**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF

The undersigned being a duly authorized representative of a member, pursuant to the provisions of Florida Statutes Section 608.411, adopts the following Amended and Restated Articles of Organization of GET REAL FILMS LLC, a limited liability company duly organized and existing under the laws of the State of Florida as filed with the Florida Department of State on October 14, 2010 (the "Amended and Restated Articles of Organization"):

OPERATING AGREEMENT


