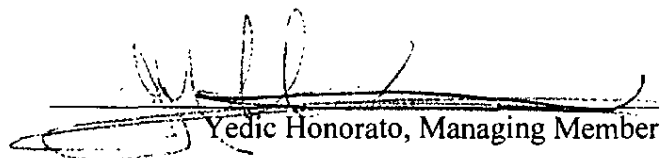

Pursuant to 608.445, Florida Statutes, this Florida Limited Liability Company submits the following articles of dissolution.

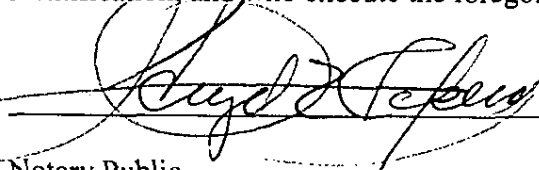
- I. The name of a Limited Liability Corporation is: **ANGELA GROUP INVESTMENTS LLC.**
