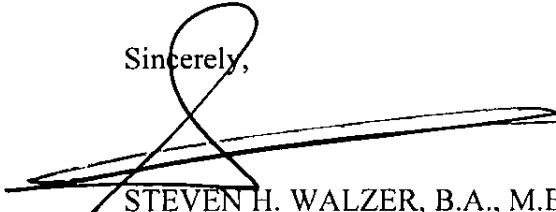

2ARTICLES OF ORGANIZATION

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the Limited Liability Company shall be *CDM + Associates of Central Florida* ~~CDM & Associates, LLC~~ ("company").

ARTICLE II - ADDRESS

ARTICLE III - DURATION

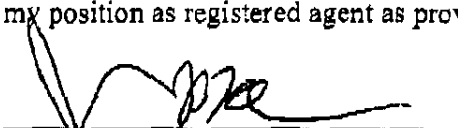

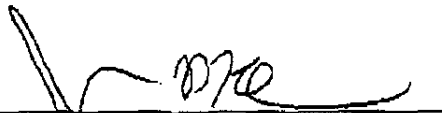
