**Principal Office**

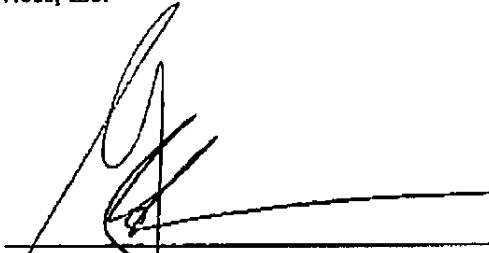
