## ARTICLES OF ORGANIZATION FOR

### UNIT 810 PUERTA DE PALMAS CONDOMINIUM, LLC

### ARTICLE I NAME

The name of this Limited Liability Company shall be UNIT 810 PUERTA DE PALMAS CONDOMINIUM, LLC (the "Company").

#### ARTICLE II DURATION
