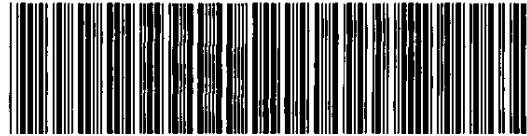

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

**ARTICLE I - NAME**

The name of the limited liability company shall be **ALL IN TIME PRODUCTIONS, LLC**, (the "company").

**ARTICLE II - ADDRESS**

The address of the principal office of the company is 3609 Trimaran Place, Tampa, FL 33607. The mailing address of the company is the same.

**ARTICLE III - DURATION**

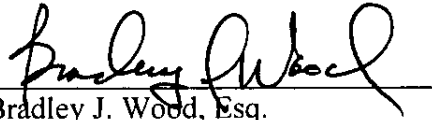

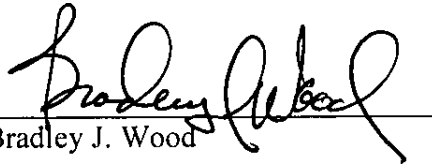
