**ARTICLES OF ORGANIZATION  
OF

The undersigned, being a duly authorized representative of the member(s), desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I  
NAME**

The name of the limited liability company is EMPOWERED YOUTH ENTREPRENEURS, LLC (the "Company").

**ARTICLE II  
ADDRESS**

The principal and mailing address of the Company is 1450 Brickell Bay Drive, Suite 411, Miami, FL 33131.

**ARTICLE III  
REGISTERED AGENT AND OFFICE**
