THE UNDERSIGNED, under the Florida Professional Service Corporation and Limited Liability Company Act, F.S. Chapter 621, hereby makes, acknowledges, adopts, and files the following Articles of Organization:

ARTICLE I. — NAME

The name of the limited liability company shall be **PEDIATRIC DENTISTRY OF CAPE CORAL, PLLC** (the "Company").

ARTICLE II. — ADDRESS

The initial mailing address and street address of the principal office of the Company shall be 9510 Bonita Beach Road, Suite 101, Bonita Springs, Florida 34135.

ARTICLE III. — REGISTERED AGENT & REGISTERED OFFICE

The name and the Florida street address of the initial registered agent of the Company shall be FARMER & ASSOCIATES, PLLC, 999 Vanderbilt Beach Road, Suite 503, Naples, FL 34108.

ARTICLE IV. — PURPOSE

The general purposes for which this Company is organized shall be to render professional pediatric dentistry to the general public, and to do all things in connection therewith that are customarily performed by licensed dentist under the laws of the State of Florida. In furtherance of its corporate purposes, the Company shall have all of the general and specific powers and rights granted to and conferred on a limited liability company by the Professional Service Corporation and Limited Liability Company Act.

ARTICLE V. — LIMITATION ON MEMBERSHIP

No one other than an individual who is duly licensed or legally authorized to render licensed pediatric dentistry services in the State of Florida or an organization described in Section 621.051 of the Florida Professional Service Corporation and Limited Liability Company Act may become a member of the Company. No member of the Company shall enter into an agreement vesting another person with the authority to exercise the voting power of any membership interest in the Company. Any member who becomes legally disqualified to render pediatric dentistry services shall sever all employment with and financial interest in the Company. No Member of the Company may sell or transfer his stock in the Company, except to another individual or an organization eligible to become a Member of the Company.

ARTICLE VI. — MANAGEMENT

The Company shall be managed by a Board of Managers and is, therefore, a manager-managed Company. Argumosa, 9510 Bonita Beach Road, Suite 101, Bonita Springs, FL 34135.

ARTICLE VII. — OPERATING AGREEMENT

Any Operating Agreement (as defined in section 608.402(24) of the Florida Limited Liability Company Act), relating to the Company, must be in writing and signed by all of the members and must comply with all of the requirements of the Act.
