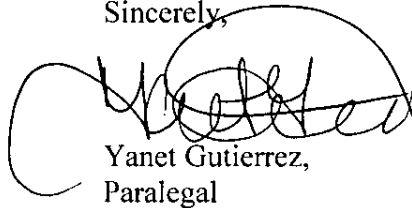

ARTICLE I
Name

The name of the limited liability company is Aquatic Toys, LLC (hereinafter called the "Company").

ARTICLE II
Principal Office

The mailing address and the street address of the principal office of the Company is 1700 East Las Olas Boulevard, Suite 302, Fort Lauderdale, Florida 33301.

ARTICLE III
Initial Registered Office and Registered Agent

ARTICLE IV
Restrictions on Membership and
Right to Continue After Withdrawal of a Member

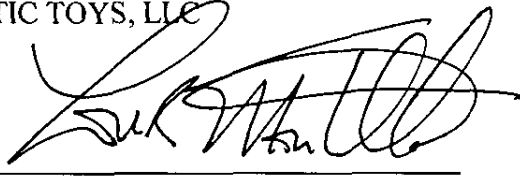
ARTICLE VI

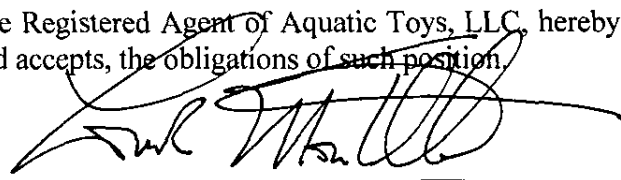
