I hereby file these Articles of Organization as the authorized representative of the member of the limited liability company to be formed pursuant to these Articles of Organization and the laws of the State of Florida.

**ARTICLE I
NAME**

The name of the limited liability company to be formed hereunder is "INNOVATIVE CONCEPT GROUP CAROLINAS, LLC" (the "Company").

**ARTICLE II

New members may be admitted to the Company as provided in the Operating Agreement.




