### SECOND ARTICLES OF AMENDMENT TO ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

#### **BLAKLEY FAMILY, LLC**

The undersigned being all of the members of BLAKLEY FAMILY, LLC, a Florida limited liability company, (the "Company"), in accordance with the provisions of Chapter 608, Florida Statutes, hereby amend the Articles of Organization of the Company as set forth below:

- 1. The name of the Company is BLAKLEY FAMILY, LLC.
- The Articles of Organization for the Company were filed with the Florida Department 2. of State on October 21, 2010, and were subsequently amended by Articles of Amendment thereto filed with the Florida Department of State on December 29, 2010 (collectively the "Articles of Organization".
- Article VIII of the Company's Articles of Organization is hereby deleted in its entirety and the following is substituted therefore:

#### ARTICLE VIII **VOLUNTARY UNLIMITED LIABILITY**

The following Members of the Limited Liability Company will be personally liable for all of the debts, obligations, and liabilities of the Limited Liability Company, to the same extent as a general partner in a general partnership:

Said Members shall continue to be personally liable for debts, obligations, and liabilities of the Limited Liability Company, until these Articles of Organization are amended to delete the Member's name from this provision. Any such amendment shall be effective immediately, except that such an amendment is not effective against persons reasonably relying upon the Articles of Organization naming the Member as individually liable for the debts, obligations, and liabilities of the Limited Liability Company, until the passage of ninety (90) days from the filing of the amendment. Notwithstanding the forgoing, such Member shall continue to be liable for all debts, obligations, and liabilities of the Limited Liability Company, incurred by the Limited Liability Company during the time that the Member was identified in these Articles of Organization as being personally liable."

- 4. These Second Articles of Amendment shall be effective upon filing with the Florida Department of State.
- 5. Except as expressly provided herein, all of the terms and provisions of the Articles of Organization shall remain in full force and effect and are hereby ratified and confirmed.
- 6. This Second Articles of Amendment may be executed in one (1) or more counterparts, each of which shall be deemed an original, but all of which together will constitute one (1) and the same instrument. The parties hereto agree that facsimile and electronically transmitted portable document format (pdf) signatures shall be deemed originals.

The execution of these Second Articles of Amendment to Articles of Organization by the undersigned constitutes an affirmation under the penalties of perjury that the facts stated herein are true and correct.
