The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **SOUTHERN STEEL MOTORCYCLE MAGAZINE L.L.C.** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 2107 Southwest Embers Terrace, Cape Coral, Florida 33991 and the mailing address shall be the same.

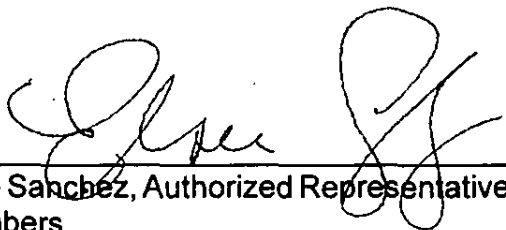
