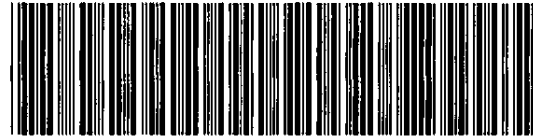



MADISON PARTNERSHIP, LLC**


