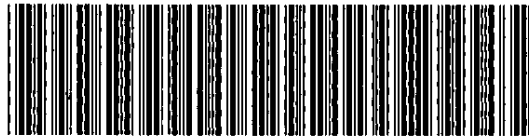

ARTICLES OF ORGANIZATION

OF

FIRST CLASS VACATION RENTALS LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **FIRST CLASS VACATION RENTALS LLC** ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 1080 Cypress Parkway, #433, Kissimmee, Florida 34758 and the mailing address shall be the same.

ARTICLE 3 - EFFECTIVE DATE

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.

ARTICLE 4 - DURATION

ARTICLE 7 - ADMISSION OF NEW MEMBERS

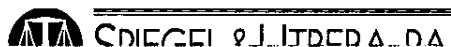
ARTICLE 9 - MANAGEMENT

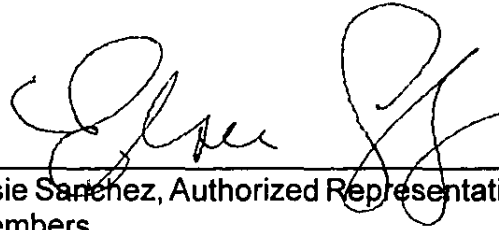

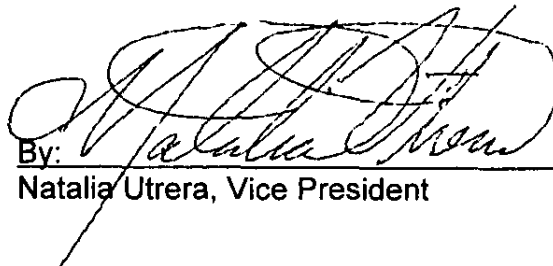
