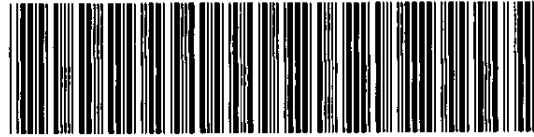

ARTICLES OF ORGANIZATION OF

ARTICLE 1 - NAME

The name of the limited liability company shall be **IT'S ALL IN THE JOURNEY, LLC** ("Company").

ARTICLE 2 - ADDRESS


