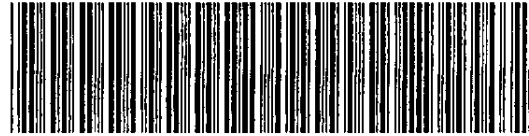

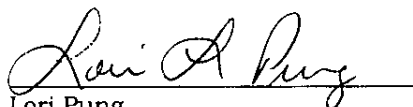
ARTICLE II. DISSOLUTION APPROVAL DATE / DESCRIPTION OF OCCURRENCE
