**ARTICLES OF ORGANIZATION
OF
CASA SOLARES IMPORT AND DESIGN CENTER, LLC**

The undersigned, being a duly authorized representative of the member(s), desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, does hereby adopt the following Articles of Organization:

**ARTICLE I
NAME**

The name of the limited liability company is CASA SOLARES IMPORT AND DESIGN CENTER, LLC (the "Company").

**ARTICLE II
ADDRESS**

The principal and mailing address of the Company is 4420 West Hillsboro Boulevard, Coconut Creek, FL 33071.

**ARTICLE III
