**ARTICLES OF AMENDMENT**  
*to*  
**ARTICLES OF ORGANIZATION**

Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Articles of Organization:

1. The name of the limited liability company is Lee Buck LLC (the "**LLC**").
2. The effective date of filing of the Articles of Organization (the "**Articles**") of the LLC was October 27, 2010.
3. The member of the LLC is Robert Lee Buck and Darla M. Buck, as Trustee of The Robert Lee Buck Living Trust (the "**Member**").
4. The Member deems it to be in the best interest of the LLC to amend Article I of the Articles of the LLC.
5. That Article I of the Articles of the LLC is hereby amended in its entirety to read as follows:

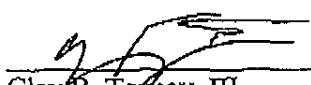
**ARTICLE I**

**NAME**
