**ARTICLES OF AMENDMENT**  
*to*  
**ARTICLES OF ORGANIZATION**

Pursuant to the provisions of Section 608.411, Florida Statutes, this Florida limited liability company adopts the following Articles of Amendment to its Articles of Organization:

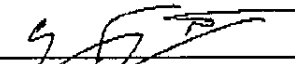
1. The name of the limited liability company is R. Lee Buck, LLC (the "LLC").
2. The effective date of filing of the Articles of Organization (the "Articles") of the LLC was October 27, 2010.
3. The member of the LLC is Robert Lee Buck and Darla M. Buck, as co-Trustees of The Robert Lee Buck Living Trust (the "Member").
4. The Member deems it to be in the best interest of the LLC to amend Article I to the Articles of the LLC.
5. That Article I of the Articles of the LLC is hereby amended in its entirety to read as follows:

**ARTICLE I**  
**NAME**

The name of the limited liability company shall be Robert Lee Buck, LLC (the "Company"). The mailing address and street address of the Company shall be 136 17<sup>th</sup> Avenue North, Jacksonville Beach, Florida 32250.

6. The foregoing amendment shall become effective as of the date these Articles of Amendment are filed with the Secretary of State of Florida.
