**ARTICLES OF ORGANIZATION
OF

The undersigned, STEPHEN W. GONZALEZ, a natural person competent to contract, hereby present these Articles of Organization for the formation of a limited liability company under the provisions of Chapter 608, *Florida Statutes*.

ARTICLE I
