The name and street address of the initial registered agent of the Company in the State of Florida is Keith Trauner, 590 Reinante Avenue, Coral Gables, Florida 33156.

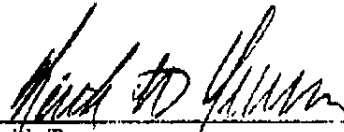
**ARTICLE IV. DURATION**
