Article III of the Articles of Organization is hereby amended to read as follows:

Article III

The purpose for which this Limited Liability Company is organized is:

The purpose for which this Company is organized is limited solely to (A) owning, holding, selling, leasing, transferring, exchanging, operating and managing the premises located at 31111 45th Street, West Palm Beach, Florida 33407 (the "Project"), (B) entering into a Mortgage Assumption Agreement (the "Assumption Agreement") with WELLS FARGO BANK, N.A., AS TRUSTEE FOR THE CERTIFICATE HOLDERS OF CREDIT SUISSE FIRST BOSTON MORTGAGE SECURITIES CORP., COMMERCIAL MORTGAGE PASS-THROUGH CERTIFICATES, SERIES 2004-C5 (the "Trust," together with its successors and/or assigns, "Lender"), (C) rofinancing the Project in connection with a permitted repayment of that certain loan in the original principal sum of \$2,700,000.00 (the "Loan") currently held by the Trust, and (D) transacting any and all lawful business for which a limited liability company may be organized under Florida state law) that is incident, necessary and appropriate to accomplish the foregoing.
