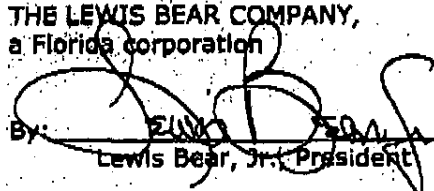
ARTICLE VII - AMENDMENT

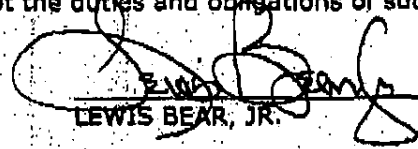
