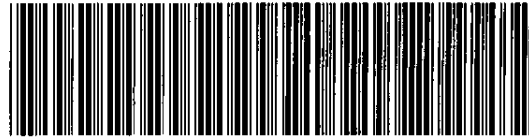



ARTICLE II- ADDRESS




