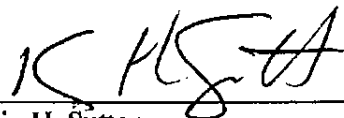

The name of the limited liability company is: Palm RV & Marine, LLC.

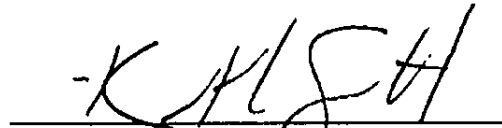

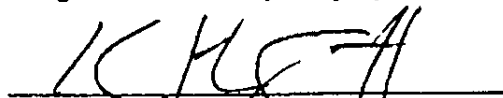
