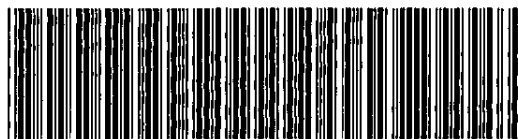

The street address and mailing address of the principal office of the limited liability company is 102 79th Street, Holmes Beach, FL 34217.


ARTICLE III - INITIAL REGISTERED AGENT
