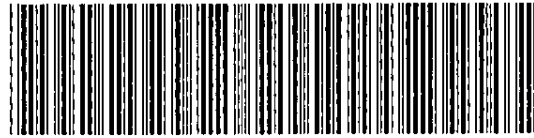

**ARTICLES OF ORGANIZATION
OF
FRANKIE & JOHNNY'S, LLC**

**ARTICLE I
Name**

The name of the limited liability company is Frankie & Johnny's, LLC (hereinafter called the "Company").

**ARTICLE II
Principal Office**

The mailing address and the street address of the principal office of the Company is 2750 N.E. 185th Street, Suite 306, Aventura, Florida 33180.

**ARTICLE III
Initial Registered Office and Registered Agent**

**ARTICLE IV
Restrictions on Membership and
Right to Continue After Withdrawal of a Member**

A member's interest in the Company may not be sold or otherwise transferred except with the consent of the members owning a majority of the interests in the Company. Upon the occurrence of any event that terminates the continued membership of a member in the Company, the remaining members shall have the right to continue the business upon consent of the members owning a majority of the interests in the Company.
