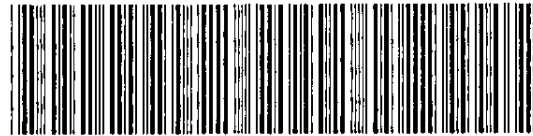

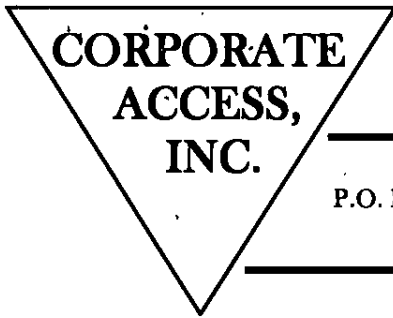

The undersigned, desiring to form a limited liability company under the provisions of Chapter 608 of the Florida Statutes, and all Acts amendatory thereto, hereby adopts the following Articles of Organization:

**ARTICLE I - NAME**

The name of this limited liability company shall be:

The initial manager shall serve until the first annual meeting of members or until her successor is elected and qualified or until her death, bankruptcy, or resignation.

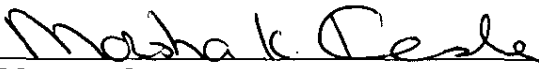
