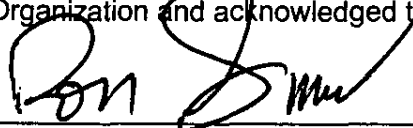
ARTICLE VII - REGULATIONS

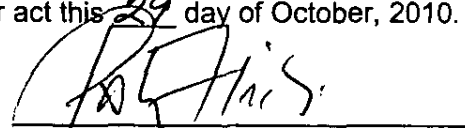
Any operating agreement of the Limited Liability Company shall be in writing and signed by all of the Members.

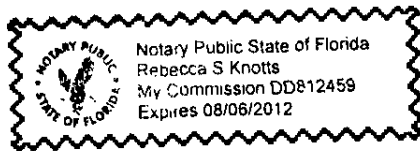
