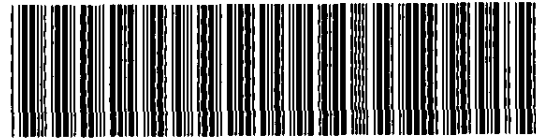


1. Name. The name of the Limited Liability Company is Amber Colvin Racing, LLC (the "LLC").

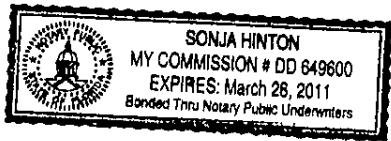


